

## **Terms & conditions for grant of scholarship to SC students**

1. Only players who are domiciles of Haryana representing the State of Haryana will be eligible for the scholarship.
2. The annual income of the family of sportsperson should not be more than Rs. 2 lakhs.
3. The sportsperson found involved in drug and anti-social behavior will not be eligible.
4. The scholarship will be given only to the students studying in Haryana.
5. The students should not have failed during the relevant year.
6. The scholarship will be given on the basis of achievements in preceding year, for a period of one year i.e. during the financial year subsequent to the year of achievement.
7. The scholarship will be given only in respect of achievements in games included in the sports policy.
8. The benefit will be given to the winners of national and international tournaments specified under the government's policy for grant of cash awards. For the state level, tournaments corresponding to the national tournaments included in government's policy for grant of cash awards will be considered.
9. The sports tournaments should have been conducted by the sports body recognized by IOC/IPC/OCA/ICSD/IBSA/SOI, as the case may be, in case of international achievements, and the Federations/Associations affiliated with them, in case of national/state achievements.
10. The highest achievement of the eligible candidate will be considered for the purpose of awarding scholarship.
11. The applicant will be eligible for cash award as well as for the scholarship.
12. The applicant who has applied for sports scholarship from SAI or Central government or any other agency on account of the said achievements will not be eligible to apply under the scheme.
13. The eligible candidate will apply in prescribed Performa to the District Sports Youth Affairs Officer of the district of which the candidate is domicile/resident of.
14. The scholarship amount will be given to sportsperson through his/her bank account.
15. Fake claims will disqualify the erring candidates from all future benefits on offer from sports department.
16. The award of scholarship will be on first-come-first-serve basis and subject to availability of funds.
17. It is an affirmative measure aimed at creating a level playing field for the weaker sections of society subject to fulfillment of conditions and availability of funds. No one will be entitled to claim it as a matter of right.

**Terms & conditions for grant of scholarship to students of  
other-than-SC categories**

1. Only players who are domiciles of Haryana representing the State of Haryana will be eligible for the scholarship.

8. The tournament should have been conducted by the sports body affiliated to the Federation/Association recognized by IOC/IPC/OCA/ICSD/IBSA/SOI/IUSF, as the case may be.
9. The highest achievement of the eligible candidate will be considered for the purpose of awarding scholarship.
10. The applicant will be eligible to apply for cash award as well as scholarship.
11. The applicant who has applied for sports scholarship from SAI or Central government or any other agency on account of the said achievements will not be eligible to apply under the scheme.
12. The eligible candidate will apply in prescribed Performa to the District Sports Youth Affairs Officer of the district of which the candidate is domicile/resident of.
13. The scholarship amount will be given to the sportsperson through his/her bank account.
14. Fake claims will disqualify the erring candidates from all future benefits on offer from sports department.
15. The award of scholarship will be on first-come-first-serve basis and subject to availability of funds.
